GENERAL GUIDELINES FOR COMPUTER and INTERNET USE

:

8. Leave the computer lab in an orderly condition.
9. Will not touch, disconnect, turn off any networking hardware.

NOT ALLOWED USE OF COMPUTER LAB

- ⇒ Illegal Activities - do we really need to describe these?
- ⇒ System Security - No hacking.
- ⇒ Inappropriate Activity - cyber bullying, naughty language, spreading of lies, you get the picture
- ⇒ Copying, Without Permission - plagiarism, copyright abuse, in other words, no cheating
- ⇒ Inappropriate Content - this includes everything from bomb building to pornography.
